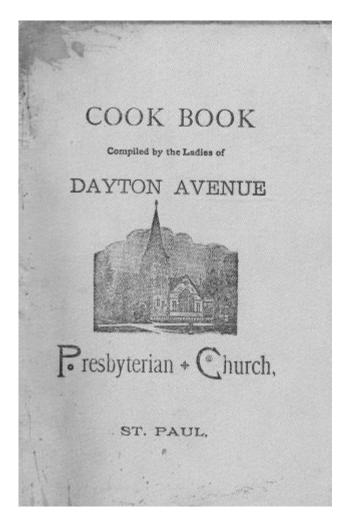
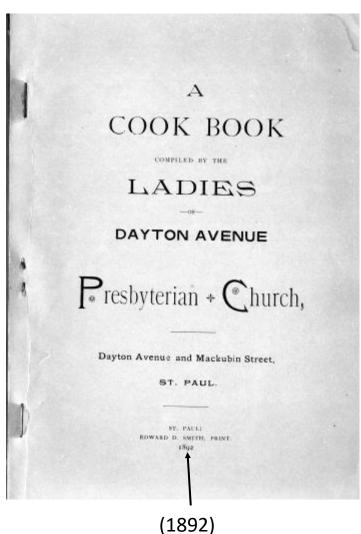
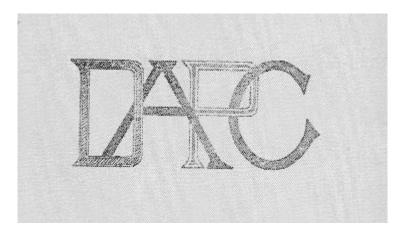

Annual Report 2017 Pastor Gary Titusdahl Dayton Avenue Presbyterian Church

I have been with you close to 2 years now. Where does the time fly?! We have held several listening sessions over this time. In these listening sessions we have tried to understand what is best for DAPC's future and its people. How do we continue honoring the core values of our church's history when financial concerns weigh us down? Time and again we have stated that our primary interest is keeping intact our worshipping community. We have said that we would like to keep the church building functioning, too, if at all possible. But the #1 goal is to keep the faith community together no matter where we would worship. An Administrative Commission (AC), created by our presbytery in July of this year, has been working with our Session to discern our next steps. We will hear specific ideas from the AC soon, if we haven't already by the time this report is presented for our annual meeting. We await word in the midst of prayer!

Through it all, we know one thing for sure. We are loved. Our church is loved! That is great, great news! We hold onto that promise even in uncertainty. We are to receive, and give, that good news in word and deed. Not too long ago, someone described me as an evangelical preacher. I wasn't sure what he meant, but it didn't sound accurate. Isn't that what conservative churches have as pastors? Then I realized that I was being complimented. An evangelical pastor preaches good news. Now, I like the sound of that! Actually, all of us are evangelicals in the church. We are bearers of glad tidings. We are practitioners of Gospel medicine! This is the world that God has loved. We are the people whom God has come to abide with and save. Thank you for your commitments this past year to live into God's love. You have been amazing with your time, and energy, and labor. You inspire me!

\It's no small achievement to live as an evangelist. Whether we are visiting someone needing care, or just going about our business, we find pressure to be cynical and despairing. People might assume that a positive person is a naïve person. We are called to keep our eyes fixed on the things of God, to live a compassionate life, and to testify to God's covenant to stay with us through the thick and thin. You and I may be the only word from God that people will ever hear. That's why God loves our church so much...we strive to be God's word in a troubled, hurting, confused world. Be that word, all you evangelists! As I said at our Christmas Eve worship, isn't it great to say Yes on Sundays when we so often scream No on other days?

I hope that on Sundays at church, or in choir practices during the week, or in meetings around the church building, we receive the gift of God's Good News. I hope that we embrace God's blessedness in order to retain encouragement. Years ago, the master preacher of preachers, P.T. Forsyth, said that, "the one great preacher is the church." My prayer for 2018 is that we continue to follow Jesus. Faith is in the following. No one can say with certainty what the new year will bring. Our call is not to cry, not to wring our hands, and not to surrender. Rather, our call is to hold onto a hope-filled vision that will give hope a new meaning. Peace!

MOA Annual Report

In the last few years I proposed retiring after a new permanent pastor was installed to replace Gary. Looking at our finances and dwindling membership and attendance, it now seems Gary may be the last pastor at DAPC (he has said that he will stay until the end). I find the idea of resigning at this point unconscionable and unfair to the health of DAPC. To look for a new MoA to work for just a few months does not seem good for the congregation or for the possible hired person. I think it took almost a year for me to absorb all the little details of this position.

As I turn 69, my present plan is to stay in place until the Personnel, Session or the Pastor request I leave. My orthopedic surgeon will not begin replacing and rehabilitating my worn out joints (knees and shoulders) at least until fall of 2018. My heart has been pronounced in good shape and I go to the gym 4-5 times a week.

My goal for 2018 is to be supportive and encourage the future direction of the congregation of Dayton Avenue. I guess that has been my goal for the last ten years!

As we move forward in 2018, along with the Holy Space Team and Stewardship, I hope to prioritize what projects need to be accomplished to keep the building viable and inviting.

Building The Future Campaign IV

Summary of 2017 for the 2016-2018 Periods

As 2017 ends, DAPC completed the second year of its fourth, three year capital campaign entitled Building The Future (BTF). A summary of the campaign is presented below. The church collected \$15,835 in 2017 toward the pledged total of \$74,000. When combined with 2016 collections, \$35,500 has been collected of the total pledged.

A portion of the remaining balance is held in the Endowment Fund and will be transferred to the BTF fund in 2018. Other 2018 collections will enable the Session to consider funding additional debt repayment, church building improvements or mission projects. In the Fall of 2018, another BTF campaign will be necessary to continue repayment of the Synod loan unless the Endowment Fund becomes obligated to repay the outstanding balance of the loan (\$177,000 at December 31, 2017) before the due date of the loan.

As a refresher, DAPC borrowed \$600,000 from the General Assembly and the Synod to renovate our church building in 2007. We began retiring these loans on a 20 year amortization schedule in July 2008. Monthly debt service was \$4,400 per month.

In August 2015, park land adjacent to the church was sold for \$295,000. At that time DAPC owed the General Assembly and the Synod of Lakes and Prairies \$261,000 and \$145,000, respectively. DAPC then restructured its debt with the Synod to pay-off the General Assembly loan. The Synod agreed to loan DAPC an additional \$50,000 and granted the church a 20 year repayment schedule on a \$195,000 note at a current market interest rate. In October 2015 DAPC paid off the General Assembly loan with \$257,000 of the \$295,000 received from the land sale. The balance of the proceeds from the land sale and the additional \$50,000 borrowed from the Synod was deposited in the Endowment Fund to support the church's general operations during the transition period following Pastor Stewart's retirement. Additional financial information is included in the Endowment Fund report located elsewhere in this Annual Report.
